RECREATIONAL ACTIVITIES (INCLUDING TRAMPOLINING) INVOLVE A SIGNIFICANT RISK OF PHYSICAL HARM OR PERSONAL INJURY INCLUDING PERMANENT DISABILITY AND/OR DEATH TO PARTICIPANTS. ANY SUCH INJURY MAY RESULT NOT ONLY FROM YOUR ACTIONS BUT FROM THE ACTION, OMISSION OR NEGLIGENCE OF OTHERS.

I (or my parent/guardian) acknowledge and warrant that:

- trampolining is an activity that involves a significant degree of risk of physical harm.
- I voluntarily and willingly assume the risk of physical harm by participating in the trampolining and any other activities at Big Boing.
- I have provided Big Boing with all relevant and necessary information that relates to my physical health and capacity to participate in trampolining and understand that if Big Boing were not provided with all relevant and necessary information about my health and capacity they would not be able to appreciate the risk of harm or injury to me whilst trampolining.
- I am not and will not at any time whilst at Big Boing be intoxicated by alcohol or affected by other drugs, whether legal or illegal.
- We do not recommend using the trampolines if you are pregnant or think you may be pregnant
- Maximum weight is 120kg of patrons to jump on the trampolines.
- Patrons have a duty to not participate in or on any trampoline court if they have pre-existing medical conditions, including but not limited to circulatory conditions, heart or lung conditions, recent surgeries, back or neck conditions, high blood pressure, any history of spine, musculoskeletal or head injury, or may be pregnant.
- Patrons have a duty to avoid landing on their head or neck. Serious injury, paralysis, or death, can occur even when landing on the trampoline bed, foam pit, air bag or padding
- I have read and agree to abide by the Rules of Big Boing.
- I accept that my conduct may affect others at Big Boing and if damage to property or injury to another occurs as a result of my conduct then I assume full responsibility for any harm done and I will not hold Big Boing responsible.
- I transfer any intellectual property rights in any material that contains myself whilst at Big Boing and Big Boing may use any photographs, footage or other images of me taken by, for or on behalf of Big Boing for promotional and advertising purposes.

To the fullest extent permitted by law, I (or my parent/guardian) hereby provide the following waiver, release and indemnity:

- (a) I will not hold Big Boing or their employees or agents legally responsible for any injury I suffer at or on Big Bong premises or using their equipment or participating in trampolining or other activities and programs; and
- (b) I will not commence any claim against Big Boing or their employees or agents for any injury suffered by me and I acknowledge that this waiver represents a legal release and discharge of legal responsibility to Big Boing or their employees or agents.

Warning – If you participate in trampolining your rights to sue Big Boing if you are killed or injured because the activities were not supplied with due care and skill or were not reasonably fit for purpose are excluded, restricted or modified as set out in this Agreement in accordance with the Australian Consumer Laws. The change to your rights as set out in this Agreement does not apply to the extent of any negligence on the part of Big Boing.
